

Ethical Wills

What is it? It is a non-binding letter or recording created for your loved ones. It is created with the intention of lasting beyond your lifetime for the purpose of passing on your faith, values, wisdom, advice and stories.



Step 1 Identify those you wish to address

Step 2-Consider you intentions and opening lines

Five Themes

- A. Your feelings- Your love and faith
- B. Your Values- gives meaning and purpose
- C. Your perspective- what life taught you
- D Your history- link to past, present and future
- E. Your will or estate plan personal context

Your Values

Your History

People, places, experiences and decisions made all the differences to me

Legacy Plans

- What are the benefits I hope my decisions and allocations bring?
- Are there provisions that might cause hurt or confusion if left unexplained
- What is the human story behind the assets that will be inherited?
- Why am I leaving a charitable contribution to Ingalls Creek or the church?
- Is there anything that worries me about the possible impact of the assets upon my heirs?



Legacy Plans- Examples Money is like Water

- I want you to know something about the source of the money you are inheriting..
- Accumulating money was not the focus of my life, meaning that...










Legacy Letters

A way to share your values, blessings, life's lessons, hopes and dream for the future, love and forgiveness with your family, rationale for financial and philanthropic decisions.




WILL: Christian Testament or Preamble




What Motivates Us to Give?

An Endowment Gift to Church's own Endowment Fund

- A designated gift that provides a long-term income stream, hopefully in perpetuity
- May be restricted or unrestricted
- May be dependent on existing or future spending policies
- Gift to a church's endowment





A Presbyterian Foundation Endowment Fund


- An outright gift to the Presbyterian Foundation for the benefit of your church
- Creates an income stream in perpetuity
- May be restricted or unrestricted
- Minimum of \$25,000 to establish






Donor-Advised Fund

- Similar to a private foundation
- Allows the donor to grant gifts to various charitable beneficiaries
- Contributions are tax deductible
- Administered by the Presbyterian Foundation
- Minimum of \$2,500 to establish



Capital Gains Tax Avoidance &

Retirement Plans

- IRAs, 401k/403(b), Keogh
- Accounts are included as part of estate
 - Heirs subject to federal income tax
- Options
 - Designate church or charity as beneficiary
 - Name charitable trust as beneficiary to provide lifetime income to person you select






HOW IT WORKS The Endow Your Pledge program offers church members an opportunity to make a one-time gift that is then distributed each year to the congregation in perpetuity.

1. The donor makes a gift of approximately 20 times their annual pledge. 2. The gift is placed in a fund with the Presbyterian Foundation. 3. Upon the donor's death, the fund makes an annual distribution to your congregation.
