- justice and reconciliation.


As a result of current trends, post COVID reduced giving and shrinking resources:

UNIFY

 The Unification Commission was established by the 225th General Assembly (2022) to oversee and facilitate the unification of the Office of the General Assembly and the Presbyterian Mission Agency into a single agency, revise the Organization for Mission to reflect this change, and work to align the entities, boards, committees, and constituent bodies of the General Assembly toward long-term faithfulness and financial sustainability of its mission within the Presbyterian Church (U.S.A.).

### A CALL TO UNIFY AGENCIES





Mandate from the Presbyterian Church USA Book of Order  "Presbyteries are responsible for raising their own funds and for raising and timely transmission of per capita funds to their respective synods and the General Assembly. (Book of Order G-3.0106)

## HOW CAN MID COUNCILS SUPPORT THIS NEW EMERGING AGENCY?

In 2022, the General Assembly directed the Co-Moderators to appoint a Funding Model Development Team. The group was appointed in December 2022 and started meeting in the spring of 2023. Since then, we have

- engaged both the history and complexity of how to fund the councils of our church.
- Prepared to offer pilots/experiments to Mid Councils where we can learn together how to fund the work of our councils in sustainable ways that match our values.



#### HISTORY

In early 2019, the 224th General Assembly directed the appointment of the Per Capita Review Committee and the Financial Sustainability Task Force. The two groups were combined into the Funding Model Team

#### Working Groups

- Per Capita Working Group: Focused on listening sessions with Mid Council leaders and developed funding options for Mid Councils and the Office of the General Assembly
- Financial Sustainability Team: Reviewed financial statements, asked questions, and provided a comprehensive resource projection analysis and summary assessment.
- Collaboration: Both teams met together frequently and shared information and feedback

#### **Recommendations :**

- Unify the Presbyterian Mission Agency and the Office of the General Assembly (current work of the Unification Commission).
- Experiment with different ways of funding the national church and Mid Councils (current work of the Funding Model Development Team).

### PURPOSE AND VISION

From the action of the 225th General Assembly (2022), the Funding Model Development Team (FMDT) is to

"develop, recruit, implement, and provide oversight of possible funding model experiments."

"develop and implement experiments that will fund councils of the church, consistent with the identified values and adaptive challenges of the Mid Councils."

receive support from the Office of the General Assembly, the Presbyterian Mission Agency, the Administrative Services Group, and the Presbyterian Foundation

collaborate with other PC(USA) entities as necessary.

### Funding Model Experiments and Goals



Seek a potential model addressing challenges to current Per Capita Funding



Participation in pilot would not result in retroactive reassessment of back per capita



Funding model team and other denominational services would support mid councils during pilot



Pilot would not be permanent change until the General Assembly of the PCUSA mandates
